Meeting Notes

Treatment Courts

During the meeting, Eric Uddin delivered a presentation on the ongoing efforts within Treatment Courts. He distributed hard copies, serving as handouts, explaining the framework of the Treatment Courts. Eric provided details about the programmatic processes and the composition of the Treatment Courts. He emphasized distinctive aspects of the Dakota County program, specifically focusing on adjudication withheld. The overarching goal of the program is for graduates to achieve sobriety and reintegrate into the community in a constructive and productive manner. Eric's presentation highlighted the commitment to fostering positive outcomes for individuals involved in the Treatment Courts.

Chemical Health

2024 Budget

Madeline shared the County Board presentation highlighting the preliminarily approval of the 2024 spending plan recommendation at \$1.3 million. The overview covered potential funding areas, earmarking \$500 from 2023 activities for school related to naloxone storage equipment and training. The presentation included the eligible funds for cities over 30K and the ineligible cities. Lastly, a breakdown of the 2024 budget – Opioid Settlement Funds. The group discussed the need for a 2024 grant process and timeline.
