


Truancy and Educational Neglect

Dakota

Truancy/ Educational Neglect by definition:

At least seven unexcused absences







Truancy is defined as students ages 12-17 who have more than 7 unexcused absences. Truancy is a Child Welfare Response.

Educational Neglect is defined as students Kindergarten to age 11 with 7 or more unexcused absences. Educational Neglect is a Child Protection Response.

Attendance Definition and Guidance



- MDE 2021-2022 Planning guidance document.
- No clear definition of an unexcused absence by MDE or DHS for 2021-2022.
- Statutory definitions remain.
- District Wide attendance policies strongly encouraged to provide consistency, and to address potential for referral disparity

Dakota County Referral Guidance



Full Day Absences Policy

Dakota County Social Services will accept a report of educational neglect or Truancy for full day absences only. This includes absences for all school models including in-person, hybrid and distance learning. In order to provide consistency across 120 schools, Dakota County has listed the following parameters to determine if a child's unexcused absences meet criteria for a referral.

- Failure to enroll in school will be reviewed by both the programs to determine the most appropriate response.
- Full day absences are defined as not attending in-person or logging on for an entire school day.
- Failure to complete in-person or online work on a given day will not be accepted as an unexcused absence.
- Failure to log-on or complete work on student flex days will not be accepted as unexcused absences by Dakota County

COVID-19 Absences due to Student or Family Illness or Exposure

If a student or their family member is unable to attend school due to COVID-19 diagnosis or exposure that requires them to be in isolation or quarantine, this absence will not be considered unexcused by Dakota County.

Referrals for Truancy or Educational Neglect in which a student has failed to provide documentation as to a positive COVID-19 will not be accepted by Dakota County.

The use of Educational Neglect, Parent Support Outreach will not be used. All screened in reports will go to Family Assessment or Truancy.

Dakota County Intervention Model



- Uses model common to Social Work Practice called "Family Systems Theory"
- Intervention is focused on family underlying needs vs a school only model.
- The Social Worker receiving the referral meets with the family and school to assess barriers.
- School attendance plan is developed
 - Educational Neglect-If student is successful in less than 45 days, the referral will be closed.
 - Truancy- Neglect-If student is successful in less than 90 days, the referral will be closed.
- If service needs are identified or if there is no improvement in attendance, case management with a case plan addressing barriers will be provided to the family.

Faxed Referral Form-Educational Neglect



- Reporter to make verbal report to Child Protection Intake
- Fax educational neglect referral form
 - Documentation of interventions attempted
 - Identify issues impacting school attendance
 - Identify current learning model
 - Special Education Contacts
 - School Principal Sign-Off
- Form posted on County Website
- Attach student services plan for 360 Family Learning Plan (with release of information)
- Attach school attendance record

Online Referral System-Truancy



Previous users may still refer, new users must seek a password and receive confirmation prior to making first referral

Truancy Portal is a communication tool as it tells county staff what interventions have already been tired

School staff able to check status of referrals.



Truancy Referrals by School Year






Educational Neglect Referrals




Truancy Referrals By District












Age at Referral

Educational Neglect-Grade










Referrals by Gender


Truancy Referrals by Race

53% of youth assigned a Truancy worker resulted in improved attendance of 90% for 45 days *at case closing.*

6% of youth referred showed no improvement in attendance and the Truancy case was closed.

99 youth assigned to a Truancy worker remained opened at the end of the school year. 35% of referred youth.
