

Healthy Minnesota Contribution Program

The Healthy Minnesota Contribution Program helps pay the cost of private health insurance premiums for adults without children with monthly gross income between:

- \$1,862 \$2,328; or
- \$2,522 \$3,153 if you are married and live with your spouse.

The program pays a monthly amount toward the cost of some private health insurance premiums. You must choose health insurance, apply, and be approved by the health insurance company. Coverage starts when the health insurance company approves your application and the premium is paid. Covered services, deductibles, and copays depend on the health insurance you buy. Dental services are not usually covered.

If you are not approved for private health insurance you may get coverage through the Minnesota Comprehensive Health Association (MCHA). MCHA may be an option if you have a pre-existing health condition. The program pays a higher monthly amount for MCHA because the premiums usually cost more.

The amount the program helps you pay each month is based on your age and household income. Below are estimated amounts the Healthy Minnesota Contribution Program pays:

| Age | Estimated monthly amount the program pays for private health insurance premiums | Estimated monthly amount the program pays for MCHA premiums |
|---------|---|---|
| 21 - 39 | \$100 - \$131 | \$120 - \$158 |
| 40 - 49 | \$140 - \$200 | \$168 - \$240 |
| 50 - 54 | \$236 - \$275 | \$284 - \$330 |
| 55 + | \$276 - \$335 | \$332 - \$402 |

If the premium for the health insurance you choose costs more than the program pays, you must pay the difference.

Example:

You choose to buy health insurance that has a \$300 monthly premium. Based on your age and income, the program will pay \$200 each month. You will have to pay \$100 each month.

You will get a Healthy Minnesota Contribution Program Approval Notice if you are approved for this program. It will tell you the exact monthly amount the program will help you pay toward the cost of premiums. The Notice will also tell you the steps you must take to get coverage.

You can start planning now!

A professional health insurance agent can help you find and apply for health insurance or MCHA coverage. The Agent Coalition can help you find an agent who has been trained about this program. There is no cost to get help from an agent. To find an agent, go to www.HealthyMNAgents.org
