**2007 Adult Felony Criminal Prosecutions in Dakota County**

**OVERVIEW**

Dakota County Attorney James Backstrom has released statistics for 2007 involving **adult felony criminal prosecutions** handled by his Office. These statistics do not reflect the total number of crimes occurring, but reflect the number of felony charges filed against individuals within Dakota County in 2007. The County Attorney is responsible for the prosecution of all felonies committed by adults (this includes persons age 18 and over and any juvenile certified for prosecution as an adult) that occur in the County. According to Backstrom:

- The total number of **adults charged<sup>1</sup>** with felony offenses in Dakota County decreased slightly (**1,891<sup>2</sup>** adults were charged with felony offenses in 2007, compared to 1,904 in 2006).

**INCREASE/DECREASE IN ADULTS CHARGED WITH FELONIES (BY CITY/JURISDICTION)**

Cities/Jurisdictions which showed an **increase** in the number of adults charged with felonies from 2006-2007 were:

- ↑ Inver Grove Heights (139 to 173)
- ↑ Mendota Heights (18 to 22)
- ↑ Rosemount (64 to 85)
- ↑ South St. Paul (106 to 132)
- ↑ West St. Paul (189 to 236)

Cities which showed a **decrease** in the number of adults charged with felonies from 2006-2007 were:

- ↓ Apple Valley (194 to 159)
- ↓ Burnsville (372 to 321)
- ↓ Dakota County Sheriff (228 to 220)
- ↓ Eagan (232 to 229)
- ↓ Farmington (55 to 42)
- ↓ Hastings (103 to 87)
- ↓ Lakeville (137 to 129)

**CHARGES DROP BUT ILLEGAL DRUG USE CONTINUES AS TOP PROBLEM**

**Drug offenses** continue to represent the largest category of cases charged by the Dakota County Attorney's Office. The total number of defendants charged with drug offenses in 2007 represents approximately 33% of the entire felony caseload of the Dakota County Attorney's Office. (See the attached chart for drug trends in the past ten years). 618<sup>3</sup> individuals were charged with felony drug crimes in Dakota County in 2007, compared to 663 the year before, a decrease of 7%.

*Backstrom commented: "Illegal drug use in Dakota County and across our state continues to be an enormous problem. The dramatic increase in drug prosecutions in our community over the last decade is a sad reminder that Dakota County is not immune from the widespread problem of illegal drug use that we have in our nation. If you include all of the property crimes committed to finance illegal drug habits and the crimes of violence associated with the illegal drug trade, it is estimated that about 50% of all felony prosecutions in Dakota County are related to the sale or use of illegal drugs."*

Backstrom indicated that methamphetamine continues to be the number one illegal drug problem in Dakota County. **330** individuals were charged with meth-related felonies in Dakota County in 2007, compared to 307 the year before (an increase of approximately 7%). In Dakota County, **6** meth labs were seized in 2007, compared to 9 in 2006. This is a significant drop, however, from the 28 meth labs seized just a few years ago in the County.

*Backstrom commented: "While it is obviously good news that fewer meth labs are in operation today, over 80% of methamphetamine sold in Minnesota is smuggled into our state, most from Mexico. Meth use continues to be a significant problem in Dakota County, as it is across our state and nation. Approximately 17% of all felony crimes charged in Dakota County last year involved the sale, manufacture or possession of methamphetamine. If you add in all of the other crimes associated with meth use (i.e. theft, robberies, burglaries and crimes of violence), it is believed that meth is involved in 25-30% of all felony prosecutions in our community."*

Backstrom noted that education of community members through Town Forums concerning the dangers associated with increasing use of methamphetamine has increased awareness by citizens which is important and must continue. In the last several years, meth forums have been held for the following communities: Burnsville, Farmington, Hastings, Inver Grove Heights, Mendota Heights, Rosemount, South St. Paul, and West St. Paul. Backstrom noted that prevention and public awareness of the meth problem is also a key project of the Minnesota County Attorneys Association (MCAA). The past two summers, the MCAA had a booth at the Minnesota State Fair to make the public more aware of the menace of meth in our state and produced a 60-minute meth documentary which is available to schools and other groups by County Attorneys throughout Minnesota. *"To effectively reduce methamphetamine use, we need a coordinated strategy of enforcement, treatment and prevention, and everyone in the community needs to be aware of the extent of this serious problem,"* Backstrom added.

The illegal manufacture, distribution, and possession of drugs continue to negatively impact the overall public health and safety of our communities. Many drug related crimes are committed by individuals who themselves are addicted to drugs. Dakota County Attorney James Backstrom continues to work with Dakota County judges, Community Corrections, law enforcement, and other criminal justice professionals to identify and implement policies and procedures to more effectively and efficiently address repeat and non-violent drug offenders who demonstrate a willingness to address their chemical addiction. The goals of this collaborative effort are to resolve cases in a more proactive way, hold offenders accountable, provide needed treatment and reduce overall recidivism.

Backstrom also praised the continued efforts of the Dakota County Drug Task Force, which consists of officers from the Dakota County Sheriff's Department and police departments in the cities of Apple Valley, Burnsville, Eagan, Farmington, Hastings, Inver Grove Heights, Lakeville, Mendota Heights, Rosemount, South St. Paul, West St. Paul and Savage. Backstrom commented: *"This coordinated law enforcement effort has been extremely effective in investigating illegal drug activity and identifying those persons involved in illegal drug sales or use. Continuation of the Dakota County Drug Task Force, which relies heavily on federal grant funding, is vital in combating the serious problems associated with the use of methamphetamine and illegal drugs in our community."*

## **DEFENDANTS CHARGED WITH MURDER**

Backstrom indicated that last year in Dakota County one individual was charged with **murder**, one individual was charged with manslaughter, and two individuals were charged with attempted murder. This was down significantly from the 17 murder prosecutions during the previous three years. *Backstrom commented: "Dakota County has historically averaged about three homicides per year (except in 2004 and 2005) and 2007 was consistent with this average."*

## **FELONY STRANGULATION CASES**

Beginning August 1, 2005, it became a felony to strangle or attempt to strangle someone during a domestic violence struggle. Backstrom praised the new law, which resulted in 68 individuals being charged with felony domestic violence in Dakota County in 2007. Backstrom commented: *"Domestic violence is a huge problem in our society and strangulation attempts signify an escalation of the level of violence in these cases. Making these serious crimes felonies was the right thing to do and will appropriately hold these offenders more accountable and provide greater protection to the victims of domestic violence."*

## **OTHER CRIMES OF VIOLENCE**

Backstrom indicated that felony charges involving **crimes of violence**<sup>4</sup> in Dakota County rose dramatically to a new all-time high, rising to **565** in 2007 up from 519 the year before (an increase of almost 9%). The ten-year average (1998-2007) for violent crimes charged in Dakota County is 390 (see the attached chart). Of significant note:

- Felony stalking charges rose from 48 in 2006 to 70 in 2007 (an increase of 45%)

- Terroristic threats charges rose from 89 in 2006 to 112 in 2007 (an increase of 26%)

- Felony assault charges rose from 210 in 2006 to 235 in 2007 (an increase of 12%)

- Felony sex-related charges rose from 78 in 2006 to 87 in 2007

- Kidnapping charges rose slightly from 11 in 2006 to 14 in 2007

*Backstrom stated: "While it is cause for concern that prosecutions for violent crime remain significantly higher than the 10-year average for these offenses in Dakota County, it is important to keep in mind that our violent crime rate is statistically quite low for the size of our County. Dakota County remains a safe community in which to live."*

## **CRIMINAL VEHICULAR HOMICIDE / INJURY AND FELONY DWI'S**

Backstrom said that two individuals were charged with Criminal Vehicular Homicide in Dakota County in 2007, one more than in 2006. Additionally, 11 individuals were charged with Criminal Vehicular Injury in Dakota County in 2007, compared with 16 charged with this crime in 2006. Also, felony DWI charges were filed against **72** defendants in Dakota County in 2007 (8 of these individuals were charged with their second felony DWI). A felony DWI occurs if an offender has previously been convicted of three prior DWI's in the last 10 years.

Backstrom said his Office coordinates enforcement and prevention activities with the Safe Dakota Coalition, made up of all Dakota County law enforcement agencies and area high schools, community colleges and organizations committed to reducing alcohol-related crashes. *Backstrom commented: "Drunk driving kills or cripples more persons each year than any other crime in America. We must continue to dedicate resources to raise the level of awareness of these dangers in our efforts to prevent these tragedies."*

In 2007, more than 500 persons were killed in motor vehicle crashes across Minnesota (an estimated 30% were alcohol-related). In Dakota County, 24 individuals were killed in 23 motor vehicle crashes (3 of these crashes were alcohol-related). *"This tragic loss of life and the debilitating injuries caused by crashes involving drunk drivers requires every effort we can make to prevent these tragedies from occurring," Backstrom added.*

## **AUTO THEFT CHARGES INCREASE**

Backstrom indicated that his Office coordinates a multi-jurisdictional auto theft prosecution unit that pursues prosecution of offenders stealing cars in Dakota, Scott and Carver counties. The number of individuals charged with felony auto theft-related offenses increased from 94 in 2006 to **126** in 2007 in all three counties. In Dakota County alone, auto theft charges rose from 68 in 2006 to **89** in 2007. Backstrom indicated that part of the state grant funding this tri-county auto theft prosecution project includes prevention efforts. Prevention efforts included law enforcement training and distribution of auto theft awareness brochures at County fairs and other community events. Backstrom commented: *“Most cars stolen are unlocked with the keys left in them. To avoid falling victim to auto thieves, drivers need to take common sense precautions like locking their cars and keeping them in garages or more secure locations overnight whenever possible.”*

## **OTHER PROPERTY CRIMES**

In reference to other **felony property crimes**:

- Welfare fraud charges rose from 125 in 2006 to 173 in 2007 (an increase of 38%)
- Burglary charges also rose from 128 charges in 2006 to 152 in 2007 (an increase of 19%)
- Robbery charges rose from 44 in 2006 to 57 in 2007 (an increase of 30%)
- Criminal damage to property charges rose slightly from 65 in 2006 to 70 in 2007
- Stolen property charges dropped from 96 in 2006 to 75 in 2007 (a decrease of 22%)
- Forgery charges were down slightly from 212 in 2006 to 206 in 2007
- General theft-related charges stayed the same at 402 in 2007

## **CRIMINAL APPEALS**

Backstrom indicated that his Office was involved in filing or responding to 79 criminal cases in 2007, compared to 77 in 2006. Appeals involve significant staff resources but are necessary in efforts to insure the fair administration of justice.

<sup>1</sup> Criminal charges are not evidence of guilt. A defendant is presumed innocent unless and until proven guilty.  
<sup>2</sup> Some of these defendants may have been charged more than one time with crimes occurring in separate behavioral incidents.  
<sup>3</sup> Some of these defendants were charged with crimes involving more than one illegal drug in the same or separate behavioral incidents.  
<sup>4</sup> Felony crimes of violence include: homicide (murder, attempted murder, conspiracy to commit murder, and manslaughter), assault, offenses involving dangerous weapons, kidnapping, robbery, sex offenses, criminal vehicular homicide/injury and terroristic threats. The statistics referenced in this section reflect the number of felony charges and not defendants. A single defendant may be charged with more than one felony offense.

3. Homicide offenses include charges for murder, attempted murder, conspiracy to commit murder, and manslaughter.

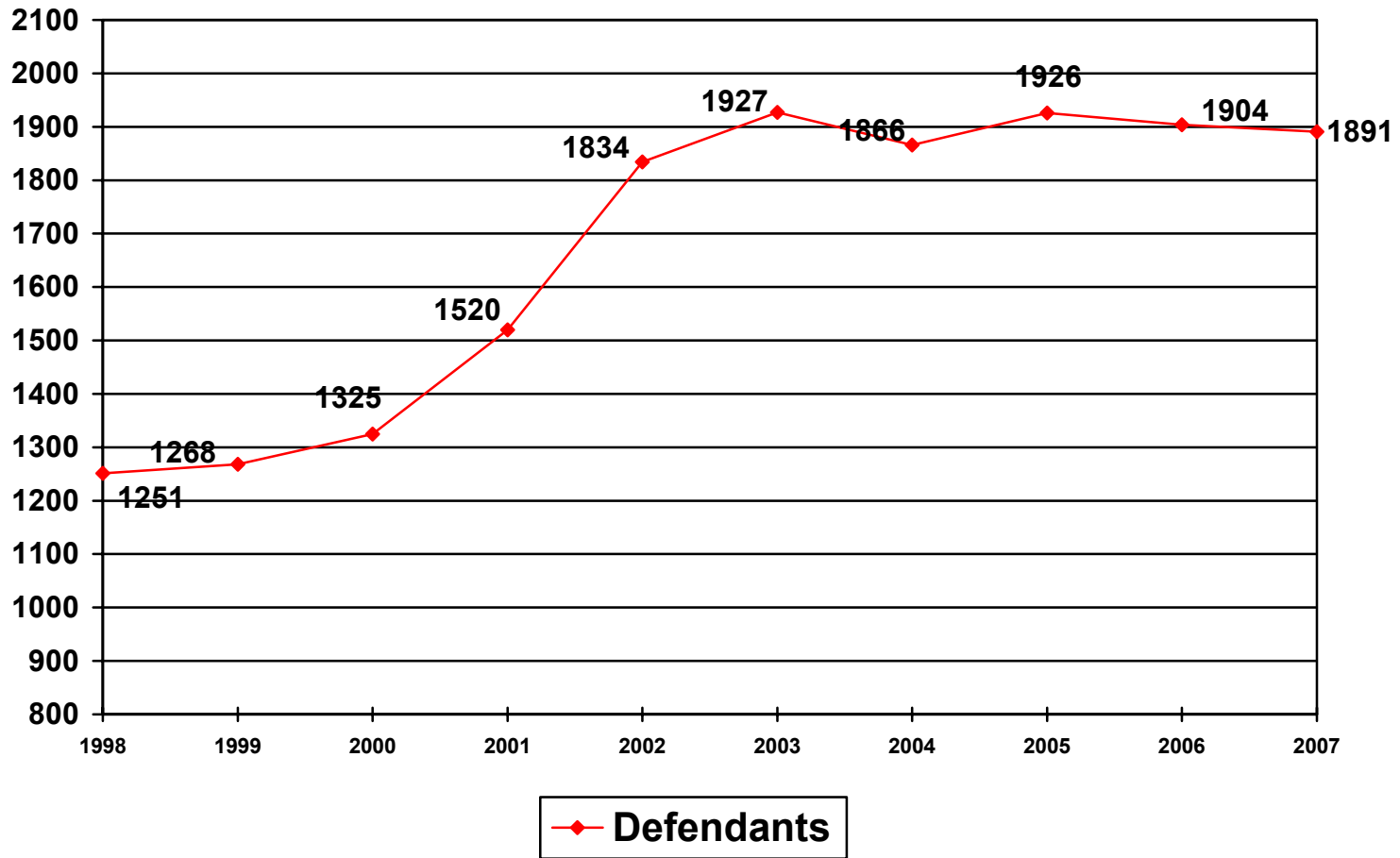
4. Criminal Vehicular Homicide and Injury includes Fleeing a Police Officer in a Motor Vehicle that Results in Death or Injury.

### 1998 to 2007

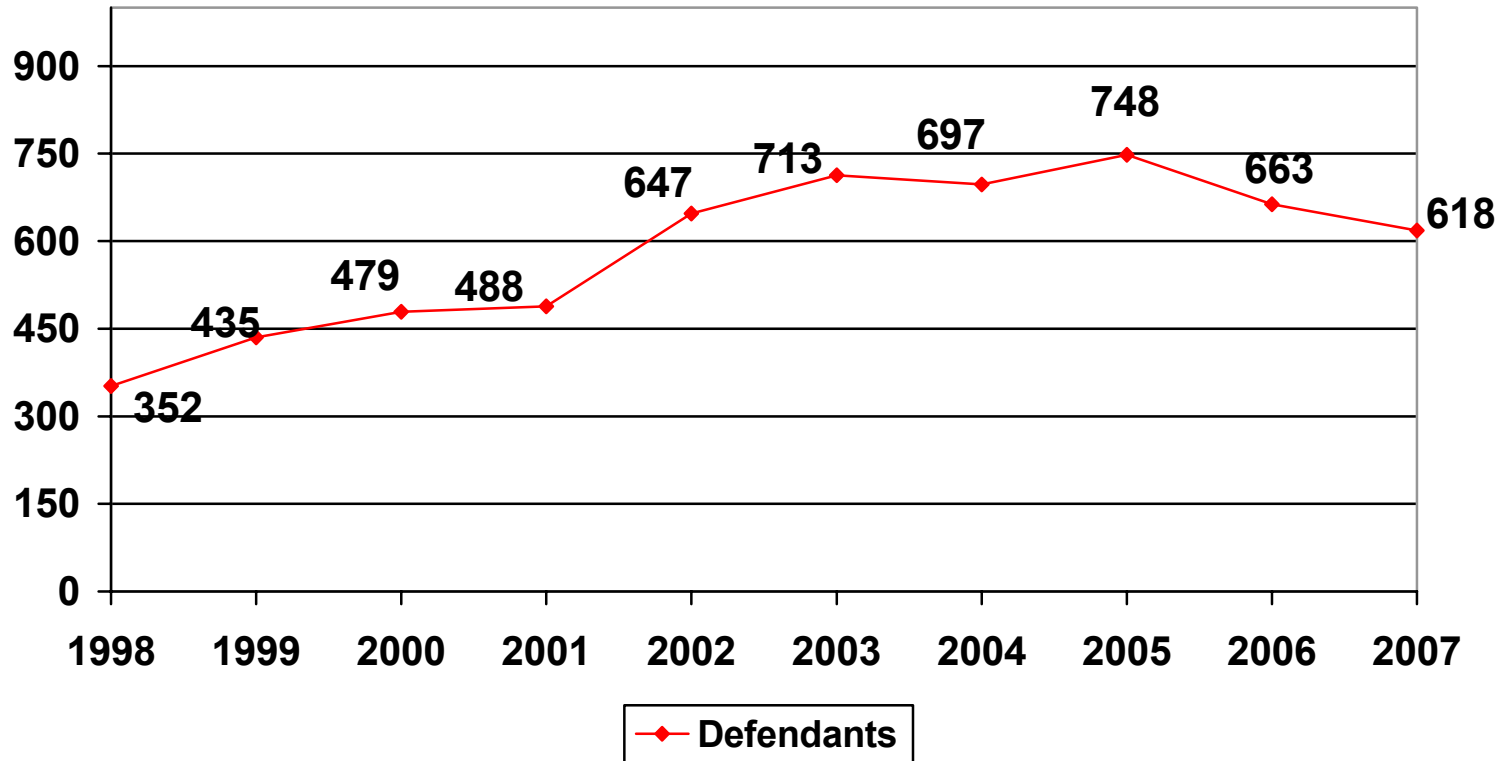
