The maximum payment to a single provider shall not exceed the weekly rate. Using any combination of hourly or full-day rates, shall not exceed the maximum weekly rate.

* Child is eligible to attend kindergarten within next 4 months (child turns 5 by May 1).

** Child is eligible to attend kindergarten within next 4 months (child turns 5 by May 10).

*** Payment for 5 hours of care or less will be paid an hourly rate.

**** A non-standard hourly rate may apply for the hours 6 p.m. to 6 a.m. Monday through Thursday and 6 p.m. Friday through 6 a.m. Monday. When billing non-standard hours add allowed amount per each non-standard hour to your total and comment how many NSH's you are billing.

Accreditation – Providers who submit valid credentials for accreditation will be reimbursed up to a 15% differential. The rates paid to a provider continues to be the basis of the maximum rate or the rate the provider charges private pay families.

These rates are compiled from a survey of Dakota County licensed family homes and child care centers. Providers in other counties will be paid according to the rate survey compiled in their county. Care provided in the child's home is based on the parent's county of residence.

County child care workers determine the amount of authorized care a parent may use.

Five hours of care or less is considered hourly. More than 35 hours of care is considered a full week.

Maximum Registration fee is \$67.18. Legally unlicensed providers cannot be paid for registration.

These are the maximum rates the county will pay for care. THE MAXIMUM RATE IS PAID ONLY IF THAT IS THE STANDARD RATE FOR THE PROVIDER. Families on Child Care Assistance cannot be charged a rate other than private pay families.

The parent must pay costs in excess of the maximum rate, as well as any co-payment.

Bills must be submitted within 60 days of the last date of service on the bill.
