

# **Approved Field Trip Destinations**

Field trips provide an eye-opening experience for students to expand their learning outside of the classroom. Students are oftentimes asked to sort recycling, organics, and trash into their appropriate bins without any real understanding of what happens to these items. Dakota County intends to bridge this gap of understanding by providing transportation for schools to have the opportunity to visit recycling facilities, landfills, and organics composting facilities to see first-hand why it all matters.

### **Guidelines and Restrictions**

Prerequisite: schools must meet recycling best practices throughout the interior of the building (Photo Documentation Form) unless a Traditional Recycling Grant has been accepted.

- Eligibility: Grade Four students, Green Team (i.e., environmental club) students Grades Five and above, and adult chaperones and school staff.
- Participants: Groups must have at least 25 participants.
- Bus availability: Busing for field trips is awarded on a first-come, first-served basis until funding for the year is allocated. Buses are provided through a contract Dakota County has with a bus company. The county cannot reimburse for busing arranged independently or through other companies.
- Bus capacity: Consider each facility's maximum group size when determining the number of buses needed. You may have the ability to drop part of the group off if traveling to two facilities near one another. Multiple buses may be requested per school to accommodate participant or location capacity.
- Filming: Ask for facility permission prior to any recording or photography onsite, as some locations do not allow.
- Waivers: Facilities may require their own waivers for completion in addition to school permission forms.
- Cancellations: To cancel the field trip, the school must notify all field trip locations and <u>schoolrecycling@co.dakota.mn.us</u> at least five (5) business days in advance before the scheduled field trip. Without advance notice, the school may lose eligibility.

#### **Choosing a Field Trip Destination**

The field trip destinations included in this document are the only field trip sites approved for bus transportation from Dakota County. Schools may choose one to three destinations from the approved list.

Field trips to organics composting facilities are not allowed if your school does not have an organics collection program currently. All schools are encouraged to visit a recycling facility and landfill.

### Before and After Your Field Trip

Planning pre- and post-field trip activities for your group will help prepare them for the field trip and reinforce and enhance the learning during and after the field trip.
