Dear Mr. Hohenstein:

The Minnesota Pollution Control Agency (MPCA) Brownfields staff in the Petroleum Brownfields (PB) and Voluntary Investigation and Cleanup (VIC) programs have reviewed the *Response Action Plan and Construction Contingency Plan Implementation Report* (the Report) dated September 25, 2014. The Report was prepared by Braun Intertec regarding the development work completed at the Cedar Grove Redevelopment Area project located at the above-referenced locations (the Site).

The Report summarizes actions to address petroleum and non-petroleum media during development of the Site. Development consisted of installation of seven single story, slab on grade buildings, with connected paved walkways, and paved parking lots. Actions taken during development included environmental monitoring of soil, excavation of petroleum and non-petroleum contaminated soil, and installation of vapor barriers and passive venting systems, where appropriate.

Based on the information provided, MPCA VIC and PB program staff has concluded that the petroleum and non-petroleum contamination were managed as proposed in the approved Response Action Plan. The MPCA VIC and PB program staff has inactivated the Site in our database. Inactivation of the Site means that the MPCA staff does not require any additional investigation and/or cleanup work at this time or in the foreseeable future in response to the identified petroleum and non-petroleum contamination.

The MPCA reserves the right to reopen this file and to require additional investigation and/or cleanup work if new information or changing regulatory requirements make additional work necessary. If you or other parties discover contamination (either petroleum or non-petroleum) that was not previously reported, Minnesota law requires that you report your findings to the State Duty Officer at 651-649-5451 or 1-800-422-0798.
