Defining Public art

- Temporary vs. Permanent Art
- Procured/Acquired/Original/Commissioned vs. Already Exist
- Artist defined as any artist, not professional
- Temporary art = period of time (like leased artwork) vs. disappears (like snow melts)

Defining Public art collection

- Portable or moveable
- Exhibition: Temporary or Permanent
- Interpretation
- Memorial
