## **Sub-Committee Reports/Updates**

### Parks Artist in Residency Pilot Program

Beth Landahl provided an update on the Parks Artist-in Residency Pilot Program. Ifrah Mansour, DC Parks Artist-in-Residence, has been developing concepts for parks that will lead towards an event at Spring Lake Park Reserve in August that focuses on weaving and natural fibers.

#### • Unity Trail Subcommittee: JuliAnne Jonker and Mike Todaro

Beth Landahl provided an update for the Unity Trail project. The joint powers agreements have been completed for the project, the RFP is being finalized by the County Attorney's Office and is expected to be released in mid-June.

#### Art Contest Subcommittee: Al Tsai

Al Tsai gave an update on the 2025 Student Art Contest. The Advisory Committee will announce the winners during intermission of Music in the Park on May 27. Al Tsai and Bob Erickson will be the emcees. Bob Erickson indicated that the Friends of the Lakeville Area Arts Center will donate gift cards for the winners again this year. Sarah Kidwell will create certificates and cards for each of the winners.

#### • Music in the Park Subcommittee: Mike Todaro

There will be five Music in the Park events at Whitetail Woods Regional Park from May through September, and one Summer Solstice celebration at Thompson Park in June.

#### Art Activities & Events Corqueboard Subcommittee: Kate Baune & Mike Todaro

Mike Todaro spoke about the Corqueboard proposal that was shared with various department heads at Dakota County to vet the idea and requirements before continuing with the concept of creating a hub for arts and culture events and activities across Dakota County.

Cheryl Caponi moved to spend \$2,500 to purchase a Corqueboard device, contingent on successfully receiving staff approval and requirements, and it was seconded by Katryna Baune. Mike Todaro abstained. The motion passed.
