Meeting Notes

Approval of Agenda: Chair

Sub-Committee Reports/Updates

Art Contest Subcommittee: Al Tsai

Al Tsai gave an update on the 2025 Student Art Contest. The Advisory Committee announced the winners during intermission of Music in the Park on May 27. There were three winners present that night, including the Grand Champion. The committee will continue to work on plans for the reception and exhibition unveiling.

Music in the Park Subcommittee: Mike Todaro

There will be five Music in the Park events at Whitetail Woods Regional Park from May through September, and one Summer Solstice celebration at Thompson Park in June. We will be able to use these events for public engagement opportunities for the public art plan.

Art Activities & Events Corqueboard Subcommittee: Kate Baune & Mike Todaro

Teresa Mitchell gave an update on the the Corqueboard presentation to various department heads at Dakota County to vet the idea and requirements before continuing with the concept of creating a hub for arts and culture events and activities across Dakota County. From the staff perspective, this is not a viable project at the moment. We are hoping that through the Public Art Framework Plan that this work and direction for the committee will emerge from this process.

Unfinished Business

Dakota County Framework Public Art Plan: Lil Leatham

Lil Leatham gave an update presentation on the Public Art Framework plan for Dakota County. The Public Art Advisory Committee will be the main advisory committee and the consultant team will plan to meet with them six times over the course of the project. The next step that will kick off are the community dialogues. The Via Partnership team will share a draft of the community engagement questionnaire with the committee at the July meeting. Then stakeholder roundtables with targeted groups of people, including local artists. There will be a list of Parks and Library events for committee members to sign up to volunteer at any of the outreach events.

Carlton County Art Commission

Teresa Mitchell followed up with the Carlton County Arts Commission about starting a public art plan. There have a different structure as a 501(c)3 nonprofit arts commission and not sure if they align closely with this committee's mission. We do have members that are willing to discuss what we do with them or if they'd like to come observe our meetings.
