Advisory committee members and others present discussed who the intended audience is for this plan and how do we best align those pieces.

After meeting with most departments across the County, Via Partnership has identified opportunities for public art that will be included in an appendix of the plan. Via Partnership does want to identify 6-10 opportunities that will be described in more detail as projects that could be ready to go. These opportunities could test different types and styles of art in plan execution.

Unfinished Business

- **Greenway Trails & Tunnels**

Mike Todaro presented the following statement that was provided by Al Tsai:

Base on:

1. 2022-2023 success of Garlough Tunnel
 - a. Staff lauded PAAC expertise and leadership
 - b. A pilot public art RFP, procurement, and installation process - a template for future Park's projects
 - c. PAAC contributed \$25,000 of PAAC funds
 - d. Stayed within budget and schedule
 - e. Aligns with County Mission and Greenway Trail Master Plan - "provide **efficient, effective, responsive government** that achieves the Board of Commissioners' vision for Dakota County: a premier place in which to live and work"
 - f. Enrichment of community and beautification of existing "drab tunnel."
2. Robert Street Tunnel
 - a. Has precedence and is of similar scope to Garlough Tunnel
 - b. Aligns with County Mission and Greenway Trail Master Plan
 - c. Aligns with River to River Greenway Master Plan

- d. Alignment with Park Mission
 - i. Near Thompson County Park / Dakota Lodge
- e. Alignment with Library Mission
 - i. Near Wentworth Library
- f. Aligns with Garlough Environmental Magnet School

Mike Todaro presented a motion, on behalf of Al Tsai, to earmark \$25,000 of PAAC funds towards commissioning public art for the River to River Greenway at the Robert Street tunnel. The motion was tabled.
