### **HIGHLIGHTS**

#### City of Farmington Fire Department

The City of Farmington Fire Department, which hired its first female employee in 2010, identified the need for lactation spaces in 2024—for both staff and the public during events. With support from Fire Chief Matthew Price, city leadership, and the Wellness/Safety Committee, two dedicated rooms were implemented at both fire stations.

#### ISD 196 Rosemount-Apple Valley-Eagan School District

The Health Services Coordinator and District Wellness Committee identified an urgent need for lactation spaces for employees returning from leave. They launched three pilot spaces with plans for district-wide expansion.

#### Thomas Lake Elementary Employee

"As a classroom teacher, I knew that going back to work was going to be hard enough, but then thinking about trying to fit pumping into my schedule seemed daunting. The lactation space has provided me with comfort, knowing I have a designated area that allows me to pump in a building full of children and staff. It has truly made a world of a difference having a spot to go to where I can pump, store milk, eat, work, and feel safe doing so."
