Ways to make Child Support Payments

Minnesota Child Support Online

MN Child Support Online (MCSO) is an interactive website provided by the State of MN to give child support clients access to important information about your case(s). This website allows you to learn about your case without having to contact your child support worker.

Information you will need to access your case: 4 digit personal identification number (PIN) Your PIN must be sent to you in a separate envelope.

You can view and print:

- Deposits or Payments
- Account Balances
- A List of Your cases
- Case Status
- Contact Information for your Child Support Workers

You can update your contact information You can send messages to your worker

Minnesota Child Support Online (MCSO) provides case information current from the time you sign in.

Other Payment Options

Income Withholding

Most payments paid on cases come from employers via income withholding.

Income withholding is a deduction from your paycheck. Child Support is deducted on the same schedule as you are paid (weekly, biweekly). We will work with your employer to set this up. Please contact us to report new employer information.

IMPORTANT: If income withholding ends for any reason, or is not enough to meet the monthly obligation, you must make payments directly to the payment center by one of the options below.

Automatic Withdrawals

Automatic-recurring withdrawal allows you to authorize Child Support to automatically deduct payments from a checking/savings account. Once the withdrawal is set up, the bank electronically withdraws your payments and sends them to the Payment Center. A blank, voided check or a pre-printed savings account deposit slip is required with your form when setting this method up.

Mail in Payment

You may pay your support by check, cashier's check, or money order.

You must identify your payments to ensure that you get credit for them and the payments are applied to the correct case. Do not send cash. Do not send payments directly to the other parent.

Be sure to include your name on your payment and at least one number, such as:
Child Support Case Number, Participant Number (MCI Number), Social Security Number

Cash Payment Options:

<u>PayNearMe</u>: PayNearMe generates a barcode that can be used to make cash payments at participating locations. PayNearMe charges the payer a \$1.99 service fee. The maximum payment that can be made using PayNearMe is \$1,000/transaction and \$2,999/rolling 24-hour period. **Participating stores:** Casey's General Store, Family Dollar, 7-Eleven, and CVS Pharmacy (stand- alone locations only, cannot be used at CVS's located inside Target).

Once you receive your barcode, go to any participating store, show the cashier your barcode, and make the payment. Barcodes can be generated three different ways:

- Using the PayNearMe app (available for Apple and Android devices)
- Going to www.PayNearMe.com/Minnesota
- Contacting your worker to request they generate a barcode via their portal

<u>MoneyGram</u>: MoneyGram is a service that allows for child support payments to be made with cash at certain retail stores. MoneyGram charges the payer a \$3.99 service fee for using its service.

Participating stores: Walmart, CVS, and Cub Foods. You will need three things to make a payment through MoneyGram:

• Sufficient cash plus \$3.99 fee • Participant Number (MCI Number) • Receiving Code: 14665



PROCESSING TIMES: Payments received at the Payment Center on Friday, Saturday, or Sunday are issued the *following* Monday.

Payments received the day before state holidays are issued the next business day. Payments made via PayNearMe/In-Person may take 3-4 business days to post to your case. MoneyGram is issued the next business day.

FACTS ABOUT CHILD SUPPORT

Why is my case open?

 Child support cases are opened when one of the parents applies for services or Public Assistance is being expended for your child(ren). Public Assistance includes Childcare Assistance, Medical Assistance, Minnesota Family Investment Program (MFIP), and Minnesota Care.

Where do I send my support payments?

• Send payments to the Child Support Payment Center at PO Box 64326, St. Paul, MN 55164-0326. Include your participant ID # or social security # to insure that payment posts to your account. If you are unsure how much to pay please contact your worker.

What are arrears?

• Arrears are the amount of back support due on your child support case. Past-due support remains due until paid in full. Interest will accrue on any arrears balance that is greater than 30 days old at a rate set annually by the state court administrator. Arrears are collected at a rate of 20% of the ongoing support obligation, unless your court order states otherwise. This is in addition to your total monthly obligation.

What will happen if I do not make my child support payments?

 The following enforcement action may be taken against you: Driver's License Suspension, Occupational License Suspension, Passport Denial, Student Grant Denial, State and Federal Tax Refund Intercept, Credit Bureau Reporting and Contempt of Court.

My address/job/phone number has changed. What do I need to do?

 Please contact your child support worker to update this information. You can leave the information on your child support worker's voice mail which is 24/7. You can also provide this information via Minnesota Child Support Online which is also available at all times.

I do not think that the balance on my billing statement is correct.

• You will not receive statements if your child support is being withheld from your paycheck. Your billing statement reflects your case status on the first day of the month. If payments for the previous month have not been received at the Payment Center by the first of the month, those payments will not be reflected on your billing statement. If you believe that your billing statement is incorrect contact your assigned support worker.

Why can't I send in my child support payments instead of my employer withholding it from my check?

All Minnesota court orders for child support require income withholding.

My employer is not withholding my full monthly support amount.

• If you are paid weekly or every two weeks, your employer will withhold less then your court ordered amount. This is due to your monthly obligation being multiplied by 12 months and then divided by 26 pay periods (if you are paid biweekly) or 52 weeks (if paid weekly). Consequently, a small arrearage will accrue every month. For those months in which there are three pay periods (if you are paid bi-weekly) or five pay period (if you are paid weekly) that extra pay period will pay off the arrearage.

What is a Cost of Living Adjustment (COLA)?

 Per Minnesota Statute, child support and/or spousal maintenance may be adjusted every two years based upon a change in the Cost of Living. A COLA is based on the U.S. Department of Labor, Bureau of Labor Statistics, and Consumer Price Index for Minneapolis/St. Paul. If you do not contest the COLA, the new amount will automatically begin charging on May 1 of that year.

The custodial parent and I are reunited. Why is child support still charging?

• Child support does not stop without a new court order. Contact your child support worker to discuss the options available to you.

Frequently Asked Questions

My Child turns 18 soon. What will happen then?

Generally child support ends when a child turns 18 years old or graduates from High School whichever occurs later. Your child support worker will need to review your court order to see when child support charging should be stopped.

I have questions about visitation/parenting time. Who should I contact?

The child support office does not address visitation (parenting time) issues. Contact your attorney or refer to the resource section of this brochure for other agencies that may be able to help you with this issue.

How can I modify my court order?

Generally, the court can modify a child support order upon evidence that the parents' current situation has substantially changed from the time of the last order. The most common examples include:

- Substantial change in income
- Health insurance availability
- Substantial change in childcare costs

How can I modify my court order?

You can either make a request to your child support worker for an administrative review of your order or you can file a motion to modify on your own or through an attorney. By requesting an administrative review, the County will decide if your case meets the criteria and inform you whether or not the county will go forward with filing a motion to modify. To file your own motion to modify, forms are available at http://www.mncourts.gov or from any Dakota County District court location.

The volunteer attorneys can provide answers to legal questions, offer procedural advice, and help fill out court provided forms.

You are required to bring any current court orders and forms pertaining to the consultation. Forms can be obtained at any Dakota County Library for 15 cents/page or online at no cost at www.mncourts.gov/forms.
