### What's Been Happening?

Happy spring! Things continue to move forward with the ASD Grant. We are officially accepting applications for individual and family grants. So far, we have approved five applications and received inquiries from many others. As a reminder of the guidelines, individuals must be a resident of Dakota or Ramsey County and have a diagnosis of autism or a related condition to qualify. Below are some examples of services and supports the grant may fund:

- Caregiver relief services (licensed or unlicensed)
- Community engagement activities, such as adaptive recreation, social clubs, etc.
- Services or items to support community integration and valued social roles
- Person-centered planning and navigation services to determine individual options for community integration
- Training for family caretakers or other providers to better support individuals with ASD or similar support needs

Dakota County recently requested Letters of Interest (LOI) from organizations to provide new or expanded community integration and caregiver relief services for people with autism and related conditions. In total, we received 39 program concepts from 19 organizations. A review committee is currently evaluating responses and selecting organizations for contracts. We plan to share more information about the organizations selected and services that will soon be available in our next update.

Finally, the grant workgroups are now wrapping up but we plan to keep their momentum going through a larger "Innovations Group" being formed. The purpose of this group is to bring together various stakeholders — including self-advocates, family members, organizations serving people with autism, policy makers, etc. — to share best practices and discuss opportunities to collaborate across disciplines in support of people with autism.
