2015 Criminal Prosecution Highlights Adult Felony and Juvenile Crimes

The County Attorney, in addition to being the legal advisor to Dakota County Commissioners and County staff, works closely with local, state, and federal law enforcement agencies to keep Dakota County a safe place in which to live and work.



JUVENILE CRIMES

In Minnesota, it is the responsibility of the County Attorney to prosecute all felony, gross misdemeanor, misdemeanor and some petty misdemeanor crimes that occur within Dakota County which are committed by juveniles (youth 10-17 years old).

• In 2015, a total of **1,029 juvenile criminal cases**¹ were charged.² Of these cases, 837 involved misdemeanor-level offenses. The number of juvenile cases charged involving felony-level crimes was 152 in 2015, the same as 2014.

Below is a 10-year history of juvenile cases charged by the Dakota County Attorney's Office:



JUVENILE CASES BY LAW ENFORCEMENT AGENCY

A juvenile prosecution begins with the filing of a citation or petition with the court. The number of youth charged with criminal offenses from year to year in Dakota County is remarkably low given our size and growth over the years. The chart below reflects the number of **juvenile cases** charged based on referrals by Dakota County law enforcement agencies for the past five years:

YOUTH ACCOUNTABILITY PROGRAMS

The Dakota County Attorney's Office coordinates a number of **youth accountability programs** for first-time offenders involved in the illegal use of alcohol, small amounts of marijuana, lower-level property crimes, disorderly conduct and fire-setting behaviors. Youth are held responsible for their criminal behavior outside of the court process, allowing them to learn from their mistakes while avoiding a criminal record.

Each program where applicable:

- Requires the involvement of a parent or guardian
- Focuses on education and prevention
- * Requires payment of restitution to the victim
- * Requires community work service
- * Requires a written letter of apology
- * Requires completion of other sanctions within a timely manner

In 2015, a total of **719 juvenile cases**³ were referred to accountability programs as an alternative to juvenile court (compared to 701 in 2014).

PEER COURT

The Dakota County Attorney's Office also coordinates and participates in **Peer Court,** a joint project with Dakota County District Court. High school students serve as jurors and identify appropriate sanctions for the juvenile offenders referred to the program. In 2015, seven area high schools hosted peer court: Eastview (Apple Valley), Burnsville, Hastings, Farmington, Lakeville North and South, and South St. Paul. In 2015, **38 juveniles** were referred to Peer Court under the direction of First Judicial District Court Judge Joseph Carter.

CRIME PREVENTION INITIATIVES


In 2015, the Dakota County Attorney's Office continued to sponsor crime **prevention efforts**, including the 26th annual **Anti-Drug/Violence Poster Contest.** In 2015, over 150 students from school districts within Dakota County submitted posters with anti-drug and anti-violence messages. In addition, over 1,000 students, staff, parents and community members attended prevention programs on such topics as **internet safety, promoting good choices, anti-bullying, safe driving,** and **mental health**. The Office also worked closely with School Resource Officers and the Safe & Drug Free School Coordinators to increase overall awareness related to youth safety. Dakota County also has a Juvenile Drug Court aimed at treatment and intensive supervision of juveniles who are addicted to illegal drugs.

ADULT CRIMES

The Dakota County Attorney's Office is responsible for prosecuting all felonies and a limited number of gross misdemeanors committed by adults (persons 18 years of age and over), and juveniles certified for prosecution as adults.⁴ The Office also prosecutes misdemeanor offenses that occur in the non-incorporated sections of Dakota County. In 2015, there were **1,766** adult criminal cases filed in Dakota County that involved a felonylevel offense. Below is a 10-year history of adult felony cases charged by the Dakota County Attorney's Office:




ADULT CASES CHARGED PER LAW ENFORCEMENT AGENCY

The Dakota County Attorney's Office reviews cases for prosecution that are submitted by local, state and federal law enforcement agencies including the Federal Bureau of Investigation, the Drug Enforcement Administration, Department of Commerce, Minnesota Bureau of Criminal Apprehension, and law enforcement agencies inside and outside of Dakota County. The following chart reflects the number of **adult cases charged** based on referrals from Dakota County law enforcement agencies for the past five years:

CRIMES OF VIOLENCE

Sadly, as the chart below indicates, violent crimes are a part of every day in America. Dakota County is not immune from this problem.

CASES INVOLVING MURDER

In total, 8 individuals died in connection with homicide cases charged in 2015 in Dakota County:⁵

9 adults were charged with murder/manslaughter (compared to 5 adults charged with such crimes in 2014)

6 adults were charged with attempted murder in 2015 (compared to 3 adults charged with that crime in 2014)

OTHER CRIMES OF VIOLENCE

In 2015, **431**⁶ cases were charged involving **625 violent crimes** in Dakota County (down from 477 cases charged involving 647 violent crimes in 2014). The following is a breakdown of these felony offenses:

8 cases of criminal vehicular homicide or injury

230 cases of assault (includes domestic-related felonies)⁷

83 cases of threats of violence

75 cases of sex-related offenses

34 cases of robbery

32 cases of dangerous weapon offenses

3 cases of kidnapping

It is important to keep in mind that the number of violent crimes in our community remains relatively low given the population of Dakota County.

ILLEGAL DRUG OFFENSES REMAIN A SIGNIFICANT PROBLEM

The increase in the number of felony cases charged in Dakota County in 2015 is primarily attributed to an increase in drug-related cases. A total of **557 cases** involving a felony drug offense were charged in 2015. The total number of cases involving a drug offense in 2015 represents almost 32% of the entire felony caseload of the Dakota County Attorney's Office. The top five drug offenses charged in 2015 are:

Meth-related	299 cases charged	(172 in 2014)
Prescriptions	81 cases charged	(73 in 2014)
Marijuana	69 cases charged	(62 in 2014)
Cocaine	49 cases charged	(36 in 2014)
Heroin	41 cases charged	(27 in 2014)

The Dakota County Attorney's Office works closely with the **Dakota County Drug Task Force**, which consists of officers from the Dakota County Sheriff's Office and police departments in the cities of Apple Valley, Burnsville, Eagan, Farmington, Hastings, Inver Grove Heights, Lakeville, Mendota Heights, Rosemount, South St. Paul, West St. Paul and Savage. The Dakota County Drug Task Force is vital in combatting illegal drug activity in our community.

The use, abuse, and possession of illegal drugs continue to be a significant problem in our community. Research has shown that the abuse of prescription medication often leads to the use of illegal street drugs such as heroin. To combat this problem, law enforcement agencies throughout Dakota County have created drop-off boxes to collect unused and expired prescription and over-the-counter medications. Residents of Dakota County are encouraged to contact their local law enforcement agency to find out more about this important service.

ADULT DRUG COURT

Many individuals who commit drug-related crimes are themselves addicted to drugs. To address this problem, the Dakota County Attorney participates in Dakota County's Adult Drug Court. This is a voluntary program that helps non-violent repeat drug offenders get the treatment they need to overcome addiction and live drug and crime free. The intensive program brings together chemical dependency and mental health specialists with professionals from the courts, social services, community corrections, and law enforcement to address addiction and mental health issues and reduce overall recidivism. In 2015, **17 adults** were referred to the Adult Drug Court program. Since the start of the program in 2008, **62 offenders** have successfully graduated.

DEATHS AND INJURIES ON ROADWAYS

Driving under the influence of alcohol or drugs remains a serious problem in our state and county. Each year in Minnesota more than 32,000 people are arrested for DWI. In 2015, 410 persons were killed in motor vehicle crashes on Minnesota roads compared to 370 in 2014. This was the largest annual increase in the number of such deaths in Minnesota since 1944. Additionally, 1,129 individuals were seriously injured in Minnesota traffic crashes last year. Approximately one out of every three traffic fatalities in Minnesota is alcohol-related. In 2015, 11 deaths occurred and 84 individuals were seriously injured as a result of motor vehicle crashes in Dakota County.

FELONY LEVEL DRIVING WHILE IMPAIRED

A felony-level DWI occurs after an individual has had four DWI's within 10 years. In 2015, there were **39** cases involving a charge of felony level DWI in Dakota County (compared to 34 in 2014).

DISTRACTED DRIVING

"Distracted driving is a growing problem that we all must take steps to prevent. These crashes are completely preventable."

James C. Backstrom Dakota County Attorney Distracted driving is also a growing problem. Each year in Minnesota, it is estimated that one in four traffic crashes are caused by "distracted" or inattentive driving (including illegal texting while driving).



FELONY PROPERTY CRIMES

In 2015, **561¹⁰ cases** involving 683 felony-level property crimes were charged in Dakota County. The following is a breakdown of the felony-property crimes charged in 2015:

235 cases involving theft-related offenses

123 cases of forgery or credit card fraud

100 cases of burglary

85 cases involving stolen property

27 cases of public assistance fraud

26 cases involving criminal damage to property

1 case involving a tax-related offense

There is a growing concern over theft offenses related to cloned credit or gift cards. In 2015, this Office charged five cases involving 14 individuals in which 375 cloned cards were recovered by investigating officers involving hundreds of individual victims with monetary losses exceeding \$66,500. Residents and businesses in Dakota County need to be extremely diligent in protecting personal and credit card data.

SERVING VICTIMS OF CRIME

In most criminal cases there are one or more victims who are emotionally, physically or financially harmed. The Dakota County Attorney's Victim/Witness Unit serves victims in an effort to minimize the impact of criminal behavior. The advocates assist victims through the criminal justice process. They lend guidance for seeking restitution, preparing victim impact statements, and attend court hearings with victims as needed. In 2015, **2,214 people** received support from the Victim/Witness Unit.

CRIMINAL APPEALS

The responsibilities of the Dakota County Attorney do not necessarily end when a criminal offender is convicted and sentenced. In many cases defendants will appeal their conviction or seek other post-conviction relief from an appellate court. This Office was involved in filing or responding to **56 appeals** in adult criminal cases in 2015, compared to 46 in 2014. Appeals involve significant staff resources and are necessary in efforts to ensure accountability for criminal offenders and the fair administration of justice.

¹ A juvenile may be charged with more than one crime in the same or separate behavioral incident.

- ² Criminal charges are not evidence of guilt. A defendant is presumed innocent unless and until proven guilty.
- A juvenile may be referred to one or more Youth Accountability Programs.
- ⁴ In 2015, no juveniles were prosecuted as adults.
- ⁵ This includes 1 death that occurred in 2014 and 1 from 2013.
- ⁶ The total number of violent crime cases differs from the combined totals of the individual listed violent crimes in this section as one defendant may be charged with multiple offenses in the same case.
- ⁷ Most domestic-related crimes are misdemeanors or gross misdemeanors prosecuted by city attorneys.
- ⁸ Most driving while impaired offenses are misdemeanors or gross misdemeanors prosecuted by city attorneys.
- ⁹ This is preliminary data from the Minnesota Office of Traffic Safety. The official number will be available mid-year.
