

You are responsible to set up a schedule with an approved community work site which includes non-profit or government agencies, schools and charitable or religious organizations. Some examples of non-profit agencies include food shelves, Goodwill, or Salvation Army. Attached is a list of pre-approved community work sites. You may use this list or seek out a non-profit organization of your choice. Please note, credit will not be given for hours performed at "for profit" companies or organizations. An example of a "for profit" organization is a retail store such as Target. If you need support locating an appropriate worksite or have general questions, please contact your probation officer directly or contact our office at DCCC@co.dakota.mn.us or (651) 438-8288.

Once you have established a site, please fill out, sign, and return the enclosed Community Work Service Agreement Form by email, mail or fax AND provide a copy of the Agreement to the work site. The site may choose to use the enclosed timecard. Please do not begin performing Community Work Service hours until your worksite has been approved by Community Corrections. Credit for Community Work Service hours will be given once Community Corrections has received your completed and signed timesheet.
