- Format: the open house style meeting included feedback activities, presentation boards, and a large plot of the project corridor. For the first activity, attendees were asked to place colored dots on the map to show where they live, work, and areas of interest. A second activity utilized a 6ft wide aerial map of the study corridor. Open House attendees were asked to place post it notes with location specific comments on the map. Project staff were available to discuss the project and answer questions throughout the event. COMMENTS

A second community survey was published on September 23rd and is still collecting responses. To date, sixteen surveys have been fully or partially completed.

Online Survey Comments - Key Themes for Intersection Improvements

- 1. How do you use the study area?
 - a. Majority (75%) of respondents live in the study area.
 - b. 62.58% access services and appointments nearby.
 - c. 50% shop nearby.
- 2. How do you and your household travel on McAndrews Road?
 - a. 100% of respondents drive the corridor.
 - b. Only five respondents (31%) walk the corridor.
 - c. Only three respondents (19%) bike the corridor.
- 3. When you walk or bike across McAndrews Road, which of these intersections do you cross the most? (Select up to 2)
 - a. 50% of respondents rarely or never cross McAndrews by foot or bike.
 - b. Aldrich Ave, Burnhaven Dr and County Rd 5 all had three responses (19%)

 - a. The age demographics skew towards older generations. 54% of households that responded had household members between 65 and 84 years old.

Comment Map Exercise – 14 Participants

A 6ft wide aerial photo map of the corridor was used for gathering location specific comments and concerns. Twenty-three post it notes had comments written on them and then placed on the map. A vast majority of the comments were regarding sightlines, requests for improved pedestrian crossings and intersection access modifications. Below is a summary of the comments that were placed on the map, based on the intersection the comment was placed nearest to.

- East of County Road 5
 - Request for pull off for buses.
 - Desire for pedestrian crossing between townhomes and Cub Foods.
- Irving Ave S
 - Three comments requesting a round-a-bout.
 - One comment requesting a stoplight.
 - Two comments requesting lanes for school buses to stop in.
 - (Townhome Development Comment) "Residents are locked in with only one access out"
 - Slip lanes for turning right onto Irving Ave S.
- 141st Ave
 - Three comments requesting a round-a-bout.
 - One comment noting challenges making left turn from 141st Ave S onto McAndrews.
- Burnhaven Dr/Fremont Ave S.
 - One sightline concern comment.
 - Two comments requesting pedestrian crossing from Fremont Ave to the south side of McAndrews.
 - Three intersection modification comments for Burnhaven Dr. Two stoplight comments and one round-about.
- Aldrich Ave S.
 - Request for longer crossing times.
 - Request for more tree cover throughout the corridor.




