COMPLAINT

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Theft (Aggregating) (Over \$1,000 up to \$5,000)

Minnesota Statute: 609.52.2(a)(1), with reference to: 609.52.3(3)(a)

Maximum Sentence: 0-5 Years and/or \$3,000.00 - \$10,000.00

Offense Level: Felony

Offense Date (on or about): 10/17/2023 to 12/09/2023

Control #(ICR#): 24000311

Charge Description: On or about October 17, 2023 - December 9, 2023, in the County of Dakota, Minnesota, LETERIUS LESHUN ROSEMAN, did intentionally and without claim of right take, use, transfer, conceal or retain possession of movable property of another without the other's consent and with intent to deprive the owner permanently of possession of the property, and the aggregate value of the property or services stolen is more than \$1,000 but not more than \$5,000.

On January 17, 2024, a detective with the Burnsville Police Department was contacted by a Target Corp. Field Investigator regarding a string of thefts occurring at multiple store locations in the metro area. The investigator found five incidents between October 17, 2023, and December 9, 2023, in which the same individual stole \$1,676.71 in merchandise from Target locations in Burnsville, Apple Valley, Shakopee, Eden Prairie, and Chaska.

The detective noted that the individual had stolen specific games from the Burnsville location on October 17, 2023. The detective searched for sales of that specific game at secondhand stores occurring on the same date. The detective learned that **Leterius Leshun Roseman (DOB: 12/04/1991)**, “Defendant” herein, had sold four video games to GameStop on the same date and after the theft occurred. The detective reviewed Defendant’s DL photo and immediately identified him to be the individual depicted stealing merchandise in all of the incidents. The detective also obtained documentation and pawn shop business records demonstrating that Defendant sold the stolen merchandise to a pawn shop.
