The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

### COUNTI

**Charge: Murder in the 2nd Degree (With Intent) (Not Premeditated)**

## STATEMENT OF PROBABLE CAUSE

On May 23, 2024, shortly after 11 p.m., Lakeville police responded to a 911 call from a female ("Witness 1") to a residence in Lakeville, Dakota County, Minnesota. Witness 1 said she thought her daughter, Bethany Ann Israel, DOB 9/11/1993, ("Victim 1") had been killed inside. When officers arrived, Witness 1 reported the following facts. Victim 1 went to the residence at approximately 6:00 p.m. that evening to have dinner with her brother, later identified as Jack Joseph Ball, DOB 4/24/2001 ("Defendant"). Family had not heard from Victim 1 and were concerned, so Witness 1 drove to the residence to check on her. Upon arrival, she saw Defendant leaving the residence and described, "he just tore out of the house." Witness 1 entered the home and saw a substantial amount of blood and then called 911.

Officers entered the residence and observed a large pool of blood on the kitchen floor under the sink and on the sink cabinets. Additionally, they observed a bloody saw, hatchet, and large, bloody, knives. As they continued moving through the house, they saw a knife on the living room floor near the staircase that led to the second level. In continuing their search, they located several dismembered body parts believed to be those of Victim 1.

Witness 1 said she believed Defendant may have gone to a cemetery in Rosemount because relatives were buried there. Rosemount and Apple Valley police officers searched for Defendant. Police received a 911 call from a residence in Rosemount reporting that a male was observed on their front door ring camera placing, what appeared to be a body part, on the front step. When officers responded to the Rosemount residence, they located a dismembered body part believed to be that of Victim 1. The responding officers observed Defendant's car parked in a nearby driveway. Defendant was located near a shed in the backyard of the residence at which his car was parked. Defendant was covered in blood on his head, shirt, arms, legs, and pants. They also observed what appeared to be a self-inflicted knife wound across his throat. Defendant was able to communicate with officers and accurately told them the date, time, and name of the current president. Upon searching the area, police found several dismembered body parts they believed to be those of Victim 1.

Investigators of the Lakeville Police Department learned in speaking with family that Victim 1 was pregnant with her first child ("Victim 2"). Additionally, while investigating the crime scene, they discovered

19HA-CR-24-1018 Filed in District Court State of Minnesota several journals and other handwritten paperwork belonging to Defendant. In his writings, Defendantswrote 024 that he was angry Victim 1 was pregnant and "no longer innocent."

An autopsy was performed by the Hennepin County Medical Examiner's Office. The medical examiner determined the manner of death of Victim 1 was a homicide and that she died as a result of complex homicidal violence. The Medical Examiner also confirmed Victim 1 was between 17 and 18 weeks pregnant with Victim 2.
