The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

Charge: Aiding an Offender (Avoid Arrest) (Harbor/Conceal)

Charge Description: On or about February 18, 2024, in the County of Dakota, Minnesota, JAYKHI JULIUS JORDAN, did harbor, conceal, aid, or assist by word or acts another whom the actor knows or has reason to know has committed a crime under the laws of this or another state or of the United States with intent that such offender shall avoid or escape from arrest, trial, conviction, or punishment, and the crime committed or attempted by the other person was a felony.

19HA-CR-24-1247 STATEMENT OF PROBABLE CAUSE

On February 18, 2024, officers responded to an armed robbery call in Apple Valley, Dakota County, Minnesota. The caller ("Victim") reported that an unknown suspect pointed a rifle at him and took Victim's vehicle.

In the resulting investigation, officers identified the carjacker as GRAYSHAUN LAMAR SMITH, born 10/06/2005. SMITH placed a bait call to Victim, who worked as a locksmith. Surveillance video from Victim's vehicle captured events after the carjacking. At one point, SMITH stopped the vehicle outside an Apple Valley residence. On the vehicle surveillance footage, SMITH is heard yelling at "Ravi" to hurry up and bring a phone charger out to him because his phone is about to die. SMITH tells "Ravi" that the charger is "in the room." Rear surveillance footage showed a male coming from the front door of the Apple Valley residence, and a door is heard opening and closing. Officers subsequently identified this male as Defendant JAYKHI JULIUS JORDAN, born 06/04/2005. Victim's vehicle was marked with a company's name and logo. Officers confirmed that Defendant stays at this Apple Valley residence.

Digital evidence further connected Defendant to SMITH'S carjacking. Defendant directed SMITH to drive the stolen vehicle to an address in Saint Paul. Evidence from SMITH'S cell phone revealed that on the date of the carjacking, Defendant called SMITH four times between 11:17 a.m. and 1:17 p.m. During the carjacking, Defendant had a conversation with SMITH around 4:46 p.m. that lasted 2 minutes and 39 seconds. When SMITH parked the stolen vehicle outside Defendant's Apple Valley residence, he was on a call with Defendant. SMITH and Defendant had additional phone calls while SMITH drove the stolen vehicle to Saint Paul. Location data from SMITH'S cell phone showed his device near Defendant's residence in Apple Valley during the hours before the carjacking.

Surveillance footage from Victim's vehicle also captured SMITH bragging that he pointed a rifle at Victim and took the vehicle. At other points, Defendant discussed getting the stolen vehicle into a garage and mentioned "crime scene." Defendant told SMITH that the Saint Paul address he sent him belonged to "DayDay" and that a third person was coming to "wipe the car down." Defendant also stated that SMITH was not "finished until you drop that off and get to Scoom's house."

Records from CashApp showed that Defendant paid SMITH \$22 at 3:52 p.m.—about 40 minutes

19HA-CR-24-1247 Filed in District Court before the carjacking. That same day at 5:29 p.m., Defendant paid SMITH \$10, which corresponded in District Court 6/25/2024 SMITH walking away after parking the stolen vehicle in Saint Paul.
