The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Burglary in the 2nd Degree (Dwelling)

Minnesota Statute: 609.582.2(a)(1)

Maximum Sentence: 0-10 Years and/or \$6,000.00 - \$20,000.00

Charge Description: On or about October 21, 2024, in the County of Dakota, Minnesota, XAVIER MARTINEZ AVILA, did enter a building without consent and with intent to commit a crime, or entered a building without consent and committed a crime while in the building, either directly or as an accomplice, and the building is a dwelling.

19HA-CR-24-2080 STATEMENT OF PROBABLE CAUSE

On October 21, 2024 at approximately 1:50 p.m., officers with the Apple Valley Police Department were dispatched to a residence in the City of Apple Valley, the County of Dakota, the State of Minnesota for a report that a Hispanic male wearing a light blue shirt with blood on it, camo shorts, and black shoes had just tried to break into the residence. While enroute, dispatch advised the male had run around the residence and was heading westbound on Germane Trail. Officers began responding to the residence and were advised by dispatch that another call had come in regarding the male at a nearby residence. The male had broken a window and gained entry into a house and was fighting with the caller's husband.

An officer arrived in the area and located the suspect male in the backyard of a residence. The male had blood on his hands and shirt. Officers detained the male and identified him as XAVIER MARTINEZ AVILA (DOB: 10/02/1976), herein the Defendant. While officers were speaking with the Defendant he became agitated and started kicking at officers. He kicked one officer in the groin, causing pain.

Officers spoke with the reporting parties. Witness 1, who made the first call, reported that she had been inside her home when suddenly the Defendant began banging on her patio door, asking to be let in. Witness 1 refused and the male got more forceful with his demands. Ultimately, the Defendant left the residence and encountered a second person, Witness 2, who was on her back patio and reported that the Defendant ran to the patio of a neighboring residence and grabbed onto a crank-out window that was partially ajar and forced it open wider, causing the cranking mechanism to be damaged and inoperable. The Defendant then jumped through the window, knocking the screen out of the frame.

Officers spoke with the reporting party from the residence where the Defendant gained access, herein Witness 3. Witness 3 reported that she had been at the computer in the room where the Defendant broke in. When he broke in, she shouted at him to "get the fuck out" but the Defendant ignored her, running further into the home and up the stairs. The Defendant eventually exited the home where he was located by officers.

Because of the blood on the Defendant's hands and shirt, officers went to his residence, where he lived with his aunt, for a welfare check. Upon arrival, officers located the silver blade of a knife lying on the stairs with blood on it. The door to the apartment was slightly ajar. Officers knocked and announced to no

response and made entry. Officers did not locate anyone in the residence, but did observe the doors to all be barricaded. In the kitchen, a burner to the stove was on and there was a cardboard paper towel tube that appeared to have been attempted to be set on fire. Officers located additional items throughout the apartment that indicated attempts to light a fire.
