19HA-CR-24-2180 STATEMENT OF PROBABLE CAUSE

On November 6, 2024, officers responded to a domestic assault call at a residence in Eagan, Dakota County, Minnesota. The caller ("Victim") advised that his son was not supposed to be at the residence and had threatened to kill Victim.

After arriving on scene, an officer met with Victim and took a statement. Victim explained that when he returned home, his son, Defendant ISAAC ALEXANDER BOUCHIE MAZE, born 11/27/1999, had punched him unprovoked in the chest. Victim noted some pain in his chest from the punch. While standing in the attached garage, Victim told Defendant that he would call the police. Defendant then went inside the house and returned holding a chef knife. Defendant advanced toward Victim in a posturing manner with the knife in his hand. This caused Victim to fear for his safety, enter his vehicle, leave the scene, and call 911.

Officers are familiar both with the residence and with Defendant. As officers attempted to arrest Defendant, a standoff ensued. An officer reached Defendant by phone. Defendant admitted to holding a knife and following Victim outside with it. Defendant advised that he would not present himself to officers because the dispute concerned only him and Victim. Defendant stated that he had continued standing outside after Victim left, hoping that police would arrive and shoot him.

Eventually, officers located Defendant in the backyard outside the residence. Defendant continued his uncooperative attitude and refused to follow police commands. Based on the circumstances, officers deployed Pepperball rounds, which resulted in Defendant's compliance and arrest.
