

TERMS AND CONDITIONS OF TRAILS BY CANDLELIGHT

TICKETS ARE A REVOCABLE LICENSE AND HOLDER ACCEPTS ALL RISK OF INJURY

This ticket is a revocable license. The ticket holder, on behalf of the ticket holder and any minor accompanying the ticket holder (individually and collectively, "Holder"), agrees to the terms herein. By using a ticket and participating in the event described on this ticket ("Event"), Holder voluntarily agrees to be bound by all of the terms of this license and Dakota County Parks Department visitor rules and policies, available at <https://www.co.dakota.mn.us/LawJustice/Ordinances/Documents/CountyOrdinance107.pdf>. Dakota County ("County") has the right to terminate the license granted by this ticket, with or without cause.

Risks, danger, and harm: Holder recognizes that attendance at the Event is voluntary and may result in personal injury (including death) or property damage. This includes all risks, dangers, and harm incidental to the Event, attendance at the Event, whether occurring before, during or after the Event, and whether in or around the Event, or any other related activities, whether such risk, danger, or harm occurs prior to, during or subsequent to any Event, including specifically (but not exclusively) the danger and harm resulting from slipping, falling, burning, soft tissue injury, sickness, cuts, skin abrasions, frostbite, allergic reactions, broken bones, or lost, stolen, destroyed or damaged property. Holder acknowledges and agrees that Holder has been adequately warned of all known or foreseeable risks, danger, and harm as described above that is associated with this Event.

BY ATTENDING THIS EVENT, HOLDER (ON BEHALF OF HOLDER AND ANY MINOR ACCOMPANYING HOLDER) IS DEEMED TO HAVE GIVEN A FULL RELEASE OF LIABILITY TO THE COUNTY AND ITS AGENTS, EMPLOYEES, VOLUNTEERS, AND CONTRACTORS. IF HOLDER DOES NOT WISH TO OR IS NOT AUTHORIZED TO GRANT ALL THE RIGHTS, RELEASES, AND WAIVERS SET FORTH IN THIS TICKET ON BEHALF OF ANY ACCOMPANIED MINOR(S), HOLDER SHOULD IMMEDIATELY ACCOMPANY THE MINOR(S) OUT OF THE EVENT.

The Holder, to the fullest extent permitted by law: (a) voluntarily assumes all risks, danger, and harm as described above that is incidental to attending or participating in the Event; (b) waives, releases, and discharges the County and its agents, employees, volunteers, and contractors from any and all negligence and liability for Holder's death, disability, personal injury, property damages, property theft, or claims of any nature which may accrue to Holder as a direct or indirect result of Holder's participation in the Event and the risks, danger, and harm as described above; and (c) agrees to defend, indemnify, and hold harmless the County, its agents, employees, volunteers, and contractors from and against any and all claims, suits, damages, and liabilities of any nature including all costs, expenses and attorney fees, which in any manner result from Holder's attendance and/or actions during this Event or the risks, danger, and harm as described above.

Holder grants permission to the County to utilize Holder's image, likeness, actions and/or statements in any live, recorded, or future audio, video, or photographic display or other transmission, exhibition, publication, or reproduction made of, or at, the Event in any medium or context for any purpose, including commercial or promotional purposes, without further authorization or compensation. Holder further releases the County from and against any and all claims which Holder has or may have for invasion of privacy, defamation, violation of any right of publicity, or any other cause of action arising out of the production, reproduction, distribution, transmission, publication, broadcast or exhibition of advertisements, promotions, content, programs and/or materials in which recordings or photographs of Holder or any minor(s) accompanying Holder appear.
