#### DAKOTA COUNTY/VERMILLION RIVER WATERSHED MANAGEMENT TAX DISTRICT

#### **AMENDED ORDINANCE NO. 127**

The Board of Commissioners of Dakota County, Minnesota, hereby ordains as follows:

Section 1. Pursuant to Minn. Stat. § 103B.231, subd. 3(b) wherein Dakota County is obligated to prepare, adopt and implement the watershed plan for the Vermillion River Watershed District located within the jurisdictional boundaries of Dakota County and pursuant to Minn. Stat. §§ 103B.211 to 103B.255 wherein Dakota County has planning, review, permitting and financing authority in the watershed district, and pursuant to Minn. Stat. § 103B.245, subd. 1, wherein Dakota County may establish a Watershed Management Tax District for the purposes of paying the costs of the planning required by law, there is hereby established a special tax district to be known as the Dakota County/Vermillion River Watershed Management Tax District.

Section 2. The territory of the Dakota County/Vermillion River Watershed Management Tax District is comprised of all lands listed below, together with all platted lands which are in the following listed tracts:

See attached legal description consisting of 14 pages with 94 map plates.

Section 3. From and after the effective date of this ordinance, Dakota County may annually levy a tax on all taxable property in the Dakota County/Vermillion River Watershed Management Tax District for the purposes for which this tax district is established. The proceeds of the tax shall be paid into a fund reserved for these purposes.

Section 4. Repealer: Dakota County Ordinance 127, which was enacted through Resolution 02-296 by the Dakota County Board of Commissioners on June 4, 2002 is hereby repealed.
