A copy of the permit must be displayed upon demand of any peace officer or officers of Dakota County. The permit will become void and subject to confiscation for any misuse. All MN Statutes, MNDOT General Conditions for Oversize/Overweight loads and Department of Public Safety Regulations must be complied with. Dakota County issues this permit to be oversize but does not guaranty the clearances needed for your load--you must inspect your route. MNDOT has approved bridge crossings without a separate state permit for legally spaced axle weights for $9 \& 10$ ton axle weight limits on Dakota County highways with up to a maximum of 220,000 Ibs. total vehicle weight. The permit may grant permission for the above vehicle movement on a Dakota county highway under the Minnesota Highway Traffic Regulation Act subject to the following:

24-hour movement nights, weekends and holidays is allowed, except for Holiday and Rush Hour restrictions. Holidays - No travel over $10^{\prime}$ wide and/or 110 ' long, is allowed from 2:00 PM the day before until 2:00 AM the day after the following holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving and Christmas Days.
Rush Hour - No movement over $12^{\prime} .6^{\prime \prime}$ wide and/or 110' long, is allowed in the cities of Apple Valley, Burnsville, Eagan, Farmington, Hastings, Inver Grove Hts., Lakeville, Mendota, Mendota Hts., Rosemount, So. St. Paul, Sunfish Lake and West St. Paul between the hours of 6:00 a.m. to 8:30 a.m. and 3:30 p.m. to 6:00 p.m. Mon.-Fri.

1. $14.6^{\prime}$ to $16^{\prime}$ wide - on multi-lane (divided) roadways, Daytime moves are allowed.
2. $14.6^{\prime}$ to $16^{\prime}$ wide - on undivided and two lane roadways, Midnight to $5: 00$ a.m.
3. Over 16 ' wide - Midnight to $5: 00$ a.m.
4. Escort vehicles as required by law.
5. Night moves: Call Dakota County Dispatch Center (651-322-2323) to notify the local police of your move.
